The Maury Express offers a deviated fixed route service to the citizens of Lexington, Rockbridge, and Buena Vista. [Routes and schedules](#) are available on the website.

A fare of 50 cents per trip is charged and must be paid when boarding the van. Exact fare is required. Children under the age of six years old ride at no charge. Washington & Lee University and Virginia Military Institute (VMI) students ride free upon presentation of a valid student identification card.

Individuals who are Americans with Disabilities Act (ADA) certified may request the van to deviate from its route to make pick-ups and drop-offs. This distance may not exceed 3/4 of a mile off the route. The [ADA certification application](#) is available on
